

FIRST FAMILIES OF EAST TEXAS - GREGG COUNTY CERTIFICATES

Are you descended from a pioneer who was living in Gregg County before December 31, 1880. The East Texas Genealogical Society is collecting and preserving genealogical records and family histories for these early settlers. Your ancestor could be included! ETGS would like to recognize your ancestor by sending you a "***First Families of East Texas - Gregg County Certificate***".

ELIGIBILITY: To qualify for a certificate, an applicant must be directly or collaterally descended from someone who was living in Gregg County before December 31, 1880. A collateral ancestor is a brother or sister of the settler who was living in Gregg County at that time. Applicants must be able to prove descent with official records for each generation. Official documentation showing that the applicant's ancestor was residing in Gregg County by this date also must be provided. Applicants do not need to reside in Gregg County or be members of the East Texas Genealogical Society.

INSTRUCTIONS: Complete the attached Application Form and Line of Descent Chart that is on the reverse side of the form. Applicants who have more than one ancestor who was living in Gregg County before December 31, 1880, and would like to have a certificate for each ancestor, should complete a separate Application Form and Line of Descent Chart for each ancestor. However, it is not necessary to complete more than one application form if the pioneer settlers were husband and wife. In that case, both their names will be inscribed on the same certificate. Make as many copies of the application form as needed. Supplemental forms such as Family Group Sheets or Pedigree Charts that contain names of children; dates and places of birth, marriage, and death; and names of spouses, including the applicant's family, may be attached to the application if desired. This would be an excellent way to preserve the information.

PROOF OF DESCENT RECORDS: Copies (DO NOT SEND ORIGINAL RECORDS) of the following Primary Source Records may be submitted as proof of descent from the early Gregg County settler: Vital Records (Birth, Marriage, and Death); Probate Records; Census Records (Local, State, and Federal); and Bible and Baptismal Records. The following Secondary Source Records may be cited as circumstantial evidence but must be supported by an explanation: Land; Tax; Military Service; Church; Cemetery and Tombstone; Obituaries; and Court Records.

Applicants are encouraged to include copies of the following Supplemental Source Records; however, they **MAY NOT BE USED** as proof of lineage: Newspaper clippings; published family histories; published county histories; published biographical records; and city and county directories. Private papers and personal records such as letters, diaries, journals, and reminiscences will be evaluated on an individual basis.

SUBMITTED MATERIALS: All applications and supporting documentation will become the property of the East Texas Genealogical Society. The Society may use any or all of the material to publish a book, or as part of the Society's quarterly publication, *East Texas Family Records*, or as part of the Society's web or internet-based publishing.

Eligibility will be determined by a committee appointed by ETGS. The committee's decision will be final. Incorrect or incomplete applications will be returned for corrections or additions.
